Congratulations Terry Buckenheimer



Dr. Terry Buckenheimer received the West Coast District Dental Association Distinguished Service Award at the organization's annual meeting in February. This award is given to a member for outstanding service toward the dental profession and the WCDDA.

Dr. Buckenheimer served as President of the Hillsborough County Dental Research Clinic, the Hillsborough County Dental Association, West Coast District Dental Association and the Florida Dental Association. He has been a Board member of the FDA Foundation for over 25 years and spent two years as its President. He also served as a Trustee to the ADA for four years and on various ADA committees. Finally, Dr. Buckenheimer was and is a Board member of the ADA Foundation and the Dental Lifeline Network. Action Requested: BOD to Hold Public Hearing on Proposed Hygiene Rules

The Florida Dental Association (FDA), along with the Florida Association of Periodontists (FAP), the Academy of General Dentistry (AGD) and several individual licensed dentists, filed a request for a public hearing with the Florida Board of Dentistry (BOD) on the proposed changes to the hygiene rules, which would move scaling and root planing and the placing of medicaments to general supervision (a dentist does not have to be in the office) from indirect supervision (a dentist must be in the office). We received notice from the BOD **that the public hearing on the hygiene rules will be held May 19** in Orlando at the DoubleTree by Hilton Orlando Airport.

So, what is the next step? We need all FDA members to send in written comments to the BOD stating why we oppose these changes. However, please include specific instances on how these changes will impact your practice, jeopardize the safety of the public and scientific evidence on why these procedures should not be under general supervision. The proponents of these rule changes have stated that they have never heard of any adverse reactions occurring when these procedures are performed. Thus, information on patients who have been harmed by these procedures will be critical to our argument. For example, a hygienist can perform these procedures today as long as a dentist is in the office. So, if an adverse reaction happens, the dentist is available and is the one qualified to jump in when bleeding, etc. occurs.

Divas Hold Another Successful Event

The annual Hillsborough Divas in Dentistry event was held on March 4 at the Empress Tea Room in Tampa. Female dentists from greater Hillsborough County convened in order to network and hear an educational and inspirational presentation by Dr. Irene Marron-Tarrazzi 1st Vice President of the American Dental Association and a Miami periodontist.

Dr. Marron-Tarrazzi discussed the latest statistics on females in the dental profession, as well as the need for more female dentists to become involved in the leadership of county, district, state and American dental associations. She underscored that need by reporting that the number of female dentists in leadership positions in organized dentistry has remained at only 20% for the past 10 years, although the number of female dentists has grown significantly during that timeframe. She urged female dentists to enhance their leadership skills through negotiating and business management training and challenged the HCDA to offer leadership training for female dentists. Dr. Marron-Tarrazzi stressed the importance of finding mentors who can provide balance as a coach, a cheerleader and a challenger.

Dr. Marron-Tarrazzi discussed ADA's Institute for Diversity in Leadership which is designed to enhance the leadership skills of dentists who belong to racial, ethnic and/or gender backgrounds that have been traditionally underrepresented in leadership roles.
